04-14-19

- An **Assault with a Deadly Weapon** occurred at 12:30am, in the 9600 block of Lower Azusa Road. Deputies responded to an assault call and contacted the victim, who was struck by an unknown person (suspect) during a disagreement. This is an ongoing investigation.

- A **Theft by False Pretenses** occurred between 1:00pm – 2:00pm, in the 9400 block of La Rosa Drive. The victim was defrauded out of money by the suspect, when they agreed to business terms over repair work on a residence.
