1. Planning Commission Meeting of November 8, 2016

2. File: PL 15-415. A conditional use permit for the establishment of an afterschool tutoring business. The business proposes to operate between 7:00 a.m. and 7:00 p.m., Monday through Saturday. The proposed maximum number of students is 20.

Associate Planner Liu gave a brief summary of the staff report.

Chairman Haddad opened the public hearing.

<u>Stanley Szeto, applicant's representative</u>, briefed the Planning Commission regarding the scope of the business. He clarified the differences in the floor plans shown in the PowerPoint Presentation and Staff Report and addressed the concerns of the Planning Commission regarding the loading area, traffic, and the turning radius.

Chairman Haddad closed the public hearing.

Chairman Haddad stated that he could not make the findings to approve this request due to ambiguity. He stated that he would prefer the applicant to return with revised plans for consideration.

Planning Manager Reimers suggested that the Planning Commission amend condition three to state that children could only be dropped off after regular school hours during the school year. He also suggested that condition four be amended to state that the space shown as the loading area shall be used for queuing, the spaces adjacent to the open spaces be used for loading, and at no time shall queuing onto Rosemead Boulevard occur.

City Attorney Thuyen stated that the Planning Commission could continue this item to January 24, approve this application as recommended by staff, or approve the item as specified by the Planning Commission.

Vice-Chair Marston made a motion to approve PL 16-462, adopt the resolution to expand the hours of operation from 6 a.m. to 9 p.m. seven days a week, allow classes at 6 a.m., and find that the project is categorically exempt.
