1. CALL TO ORDER

Vice Chairman Catalan called the Transportation and Public Safety Commission Meeting to order at 7:41 p.m.

Public Safety Supervisor Ariizumi announced that the City Council voted to reinstate Overnight Parking Enforcement; enforcement to begin on October 5, 2021 at 2am. A 75-day warning period began on July 29th. City staff has begun accepting Overnight Parking Permit applications, in person at City Hall by appointment, by mail and online on the City's website. He informed the Commission regarding future meetings and how those meetings will be scheduled. Lastly, he reported that 300 pounds of illegal dangerous fireworks were confiscated and removed from Temple City Streets during the Firework Suppression Operation, conducted by City Staff and the Los Angeles County Sheriff's Department on, July 3 and 4, 2021.
