At the Special meeting of August 16, 2022, the City Council:

- Adopted Resolution No. 22-5620 authorizing the use of teleconferencing or videoconferencing for Brown-Actcovered public meetings of the City Council and City Commissions for a period of 30 days;
- Received and filed the Visa Card Report;
- Adopted Resolution No. 22-5621 approving payment of bills for Fiscal Year 2021-2022;
- Adopted Resolution No. 22-5622 approving payment of bills for Fiscal Year 2022-23;
- Approved the creation of an EV Charge Station fee and amendment of the adopted Fiscal Year 2022-2023 Master Fees and Fines Schedule to reflect the new fee by resolution on September 6, 2022;
- Approved the Minutes of the Regular Successor Agency to the City of Temple City Meeting of July 5, 2022;
- Adopted Resolution No. 22-5623-SA approving payment of bills for the Successor Agency;
- Received updates from the City Attorney and City Manager; and
