

CITY OF TEMPLE CITY CITY COUNCIL MEETING ACTIONS

These are some of the City Council actions from their meeting of June 20, 2023. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the Special Budget Study Session of June 20, 2023, the City Council:

- Met to discuss and give staff direction on the proposed Fiscal Year 2023-2024 city budget.

At the Regular meeting of June 20, 2023, the City Council:

- Directed the City Clerk to administer oath of office to the city commissioners serving the terms of July 2023 to June 2025 and presented them with a certificate of appointment;
- Received and filed the City Council Special Meeting Minutes of June 6, 2023 and Regular Meeting Minutes of June 6, 2023;
- Adopted Resolution No. 23-5673, adopting the Statement of Investment Policy for FY 2023-2024;
- Accepted project completion for the City Hall trellis replacement project, capital improvement project (CIP no. P23-07) as performed by Concept Consultant, Inc. for a total amount of \$316,868.05, authorized the City Manager to file a project Notice of Completion with the County of Los Angeles Registrar-Recorder, and authorized the City Manager to release a retention payment of \$15,843.40 to Concept Consultant, Inc. within 35 days following recordation of the Notice of Completion;
- Authorized the City Manager to execute a second amendment to the agreement with West Coast Arborist, Inc. (WCA) for tree maintenance services;
- Authorized the City Manager to execute the Second Amendment to the agreement with Southland Transit Inc. for transportation maintenance services;
- Authorized the City Manager to execute the Second Amendment to the agreement with United Maintenance Systems, Inc. (UMS) for Citywide Janitorial Services;
- Adopted Resolution No. 23-5682 authorizing the payment of bills;
- Adopted Resolution No. 23-5679 approving the Master Fees and Fines Schedule for Fiscal Year 2023-2024;
- Continued the public hearing for the Proposed Budget for Fiscal Year 2023-2024 and the Appropriations Limit to Friday, June 23, 2023;
- Authorized staff to proceed with the preparation of the bid package for the selected streets in the Fiscal Year 2023-2024 Street Rehabilitation Project;
- Received updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
